This contract regulates the ownership and use of photographs or video, as well as any derivative works based thereupon, taken by the above-named photographer ("Photographer") of the above-named model ("Model"), taken this day (collectively, "the Work").

1. Model has agreed to be photographed and/or video and sound recorded in exchange for a one-time payment or other valuable consideration, the receipt and sufficiency of which is acknowledged by Model.
2. Permission is specifically granted to Photographer to edit, alter, and distort the Work, to use the Work in whole or in part, in conjunction with other images, graphics, text and sound in any way whatsoever and without restrictions.
3. Permissions granted under this Agreement are absolute and final. Photographer's rights shall not be subject to further inspection or approval by Model at any stage in the use of the Work.
4. Use of the Work shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium whatsoever, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.
5. Use of the Work may be in conjunction with Model's own name or a fictitious name unless a preferred modeling name has been specified above, in which case the Work may be used in conjunction with that preferred name or another fictitious name, but shall not be used with Model's legal name without explicit, written consent.
6. Photographer shall own all rights in the Work exclusively, including—but not limited to—copy rights.
7. To the extent that any part of the Work shows uncovered nipples, pubic hair, or genitals, those image must not be displayed or published unless cropped or edited so the nipples, pubic hair, and genitals are no longer visible in the final image or Model explicitly consents to their use in writing. This restriction applies in full force to any third party to whom publication rights for said images are transferred and/or licensed. Any resulting images that contain nipples, pubic hair, or genitals must be deleted by Photographer upon written request from Model.
8. Model warrants having read and understood this Agreement and further warrants being of full legal age to enter into an agreement.
9. With full knowledge of the above, Model hereby releases and shall hold harmless Photographer and their successors, legal representatives, licensees and assigns from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.
10. Any rights or permissions granted under this agreement shall extend to their owner's successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual.
11. This Agreement shall be construed, interpreted, and governed in accordance with the laws of the State of _____ and should any provision of this Agreement be judged by an appropriate court as invalid, it shall not affect any of the remaining provisions whatsoever.

If this box is checked, there are specific exclusions, limitations, or restrictions either listed on the opposite side or attached on a separate sheet and initialed by both Guardian and Photographer. Any listed exclusions, limitations, or restrictions shall take precedence over the terms enumerated above.
